## MIHAJLOVIC MEETS AKTOR'S PRESIDENT TO DISCUSS CORRIDOR X WORKS

BELGRADE, 31 January 2017 (Beta) - Serbian Minister of Construction, Transportation and Infrastructure Zorana Mihajlovic met on Jan. 31 with the president of the Greek Aktor company, Dimitrios Koutras, to discuss the company's construction works along the Serbian route of Corridor X. The minister and the Aktor president analyzed the status of the four legs of the Corridor X East, 48 kilometers long in total, where the Greek company is the contractor, Mihajlovic's ministry said in a press release after the meeting. Koutras presented to the Serbian

minister a new draft version of a very dynamic plan to complete the works, which the "ministry will analyze in the next seven days," the press release says. The next meeting has been scheduled for Feb. 8, the ministry announced
